FOR YOUR BENEFIT

The CAT Board has been recruiting for a new Executive Director during the past three years. I have spoken with several people about the position and talked with others for suggestions of people they thought might be a good Director. The people I spoke to were either too busy, too far away from Sacramento, or after discussing the job with their family decided to decline to apply. All said they were honored to be asked to apply for the position. As a result, the CAT Board with the membership's approval will add "Executive Director Committee" to the CAT By-Laws. The language follows:

If the Executive Director's position becomes vacant, and a replacement cannot be found: The CAT Board shall appoint a person to represent CAT on Automotive and Industry related Boards and Associations that are mutually beneficial to CAT and its membership. The Boards and Associations CAT is affiliated with are, but not limited to the following.

<u>Automotive Service Councils of California (ASCCA)</u>: participate in Team Weekends and join relevant committees.

Bureau of Automotive Repair Advisory Group (BAG): participate in the quarterly Advisory Group meetings.

<u>California Automotive Coalition (CalABC)</u>: attend the quarterly board meetings and participate in monthly conference calls.

California Industrial and Technology Education Association (CITEA): participate in the yearly conference.

<u>California Automotive Wholesalers Association (CAWA)</u>: participate in the summer and winter educational forums and the fund-raising gala at the SEMA show.

California Department of Education (CDE): participate in the industry advisory committee meeting.

<u>Legislative Lobbyist:</u> Designate a person to establish a relationship with the lobbyist for ASCCA and CalABC to stay informed on legislative activities and attend CTE legislative committee hearings.

<u>Capital Legislative Day:</u> As many people as possible (at least one person) should attend the "Legislative Day" and participate in visiting legislators for the Industry and Career Technical Education.

Each person will submit an expense report to be reimbursed for travel expenses to the meetings to CAT Executive Treasurer at least twice a year.

Write an association report for the CAT Newsletter. The Newsletter editor will organize the reports into a single report for the Newsletter.

Give an Association report at all CAT Board meetings.

The interim assignments will be:

ASCCA - Wendy Lucko who is a member of the ASCCA Board.

BAG - Ruben Para who is a member of the advisory group.

CalABC - Pete Escoto will be responsible for attending CalABC board meetings and monthly conference calls.

CITEA - we are looking for a CAT member who attends the CITEA conferences who could give a board report.

CAWA - Donal Howell who will be appointed to the CAWA Board.

California Department of Education - Armando Hernandez who is a member of the Advisory Group and other committees.

Wendy and Pete will work with Jack Molodanof who is the legislative advisor for ASCCA and CalABC.

Wendy has attended the Capital Legislative Day in the past and plans to continue doing so.

IMPACT

Be prepared to develop courses for the new regulations and guide them through the approval process as the Governor signs the AB 471 bill into law. Highlights of the bill are;

- **Protects Consumers and Enhances current BAR Programs.** AB 471 focuses on the protection of consumers and enhancing current BAR programs by easily verifying and identifying auto repair shops that have proper training and certification credentials.
- Improves BAR Citation and Fine Program. The bill improves the current citation and fine regulatory

program by creating an independent citation conference panel to review citations; allows BAR to certify providers that train auto repair dealers; and provide opportunity for repair shops to attend training for minor paperwork citation violations, like traffic school.

• **Protects Consumers who Purchase Revived Salvage Vehicles.** Combines and renames the current brake and lamp program to the vehicle safety inspection program and provides BAR the authority to develop additional inspection criteria thru regulation.

PERSONAL





A Unit Plan for Automotive Fundamentals



Do you teach an *Introduction to Automotive Technology* or *Automotive Fundamentals* course? What should be included in a unit plan on electric vehicles (EVs) within your introductory course? The key question to ask is, "What should every beginning automotive student know and be able to do regarding EVs?"



The Paradigm is Shifting

When there is a paradigm shift, a movement begins as the prevailing technology is replaced by a new technology. Think of how this change occurred when cell phones became the new way of communicating over landline phones. Another example is how listening to music changed from records to 8-track tapes to cassettes to CDs to MP3 players to streaming on your smart speaker. Depending on how old you are, you may have never experienced the former technologies. Paradigms can change quickly or gradually over time. A transformation in the automotive industry is occurring. While many alternative fueled vehicles have been proposed for years, the EV is emerging as the preferred technology. Battery technology has been at the forefront of this transformation. As the cost and weight of an EV battery is reduced, the price of an EV is edging closer to the price of an internal combustion engine (ICE – gasoline and diesel) vehicle. Range anxiety is less of a factor due to battery efficiency. The number of public charging stations are increasing, allowing for long distance travel. The demand for EVs is significantly growing. Governments have or are beginning to make projected bans on new ICE vehicle sales in the near future. This movement, plus the increase in carbon emissions into the environment, is accelerating the adoption of EVs. The paradigm shift from ICE vehicles to EVs is occurring right now.



A Unit Plan - Electric Vehicles


If you only have one semester to teach all the basics, what should be dedicated to EVs? You have a lot to cover in an intro class. Students need to know about safety, tools, automotive systems, and more. A unit plan (about a week or two) on EVs could be integrated into your fundamentals course. This unit plan could include the following: Introduction to EVs, EV Timeline, How EVs Work, EV Components, High Voltage Safety, EV Emergencies, Charging an EV, Buying an EV, Driving an EV, Maintaining an EV, EV Conversion Kits, and Automotive Manufacturers that are producing EVs.

VEHICLES RETIRED BY THE CONSUMER ASSISTANCE PROGRAM ARE AVAILABLE FOR INSTRUCTIONAL PURPOSES

SCHOOLS WILL NOT BE CHARGED FOR USE OF VEHICLES

- Transportation to the school and back to the dismantler must be arranged by the school at its own cost.
- Vehicles must be returned to the dismantler by May 30, 2022. However, they may be returned or exchanged earlier depending on availability.
- Schools must sign a memorandum of understanding with BAR.

INSTRUCTORS CAN USE THESE VEHICLES TO

- Teach mechanical and auto body repair techniques.
- Design troubleshooting activities for students.
- Disassemble systems as needed to demonstrate principles of operation.

STUDENTS CAN GAIN HANDS-ON EXPERIENCE

 Assembling, disassembling, and troubleshooting vehicles as needed to complete assignments.



- California college under-graduate in the automotive service field.



Good News Can't Wait

My own program has benefitted from recent funding sources, allowing us to begin offering Hybrid, Electric & Alternative Fuel Vehicles training. The pilot program is being run through contract education by our Training Resource Center, but the classes and lab activities take place in our home facility. Many of our current and former students are attending, as well as shop owners and technicians from the surrounding community. This not only brings important training for the future, but further establishes connections with those industry members who will be employing our graduates.

While it may seem a small thing to some, another recent improvement has been the hiring of a lab technician. We are only able currently to use a student worker, but I have been blessed with a great employee and partner who is able to come alongside and direct the hands-on activities. He is able to share knowledge with the other students as a peer, all the while increasing his own knowledge and improving his presentation skills. I hope our administration will see fit to hire at least a part-time lab technician as a classified employee soon, but right now, I am grooming this student to be my next adjunct instructor.

One of the biggest pieces of good news is that the college and the city have approved the building of a brand-new facility to house several Industry & Technology divisions, including Automotive. We are still in the planning stages, and were told the new place will basically house what we already have in our present location, but the opportunity to work with something new and improved is exciting! I could even see our college being able to host a CAT conference in the next few years.

Please remember you are not alone, that others stand beside, behind, and ahead of you to lead and guide along the sometimes dark paths we walk. CAT will continue to be a resource, but it relies on its members to build up and support one another.
